Update 7/10: God bless everyone. Plans are for me to begin Chemo Therapy on 7/18/12. I will take Xeloda for 14 days followed by 7 days rest. This is considered to be 1 cycle of treatment which is repeated for 8 cycles; a total of 24 weeks or 6 months. I am building up strength to begin the treatments. I have a home care nurse seeing me 3 times per week now. I am also learning how to take care of the Colon-Ostomy pouch to keep it from leaking. God bless you and Lady Janet and all your loved ones. Update 6/19: Hello everyone! Phoenix is doing very well this past month or so. She is feeling pretty good. She is active and happy for the most part. She is entering into a short recovery period, which will give her a bit of a break from the intense chemo treatments. She will begin Direct Cranial Radiation sometime soon, and that will be a ten day process. We are hoping it will not be severely taxing on her. We are grateful for the progress she has made, and I was feeling blessed to share Fathers day with my baby! Thank you all for being concerned still and for being strong enough to continue your prayers during these long treatments. It is making a difference and so far the summer has been good to her! She has a long road, and it has ups and downs, but our destination is recovery and we will keep moving until we find ourselves there! John

Update 7/2: Phoenix was able to get started on her oral (at home) chemo on Friday, which means her body has finally recovered from the last round of infused chemo, so yay for that. We are going to visit University Hospital tomorrow morning for a consultation and exam with her radiation doctor and team. After the holiday she will undergo 2 weeks of cranial radiation, to attack any cancer that may have entered her brain during her initial bleeds back in October. She is still feeling great and enjoying summer! We have had the pleasure of visiting with many of you over the past month, and it has SO rejuvenated our spirits! We love you all.

Update 7/10: Our little girl begins her Direct Cranial Radiation this morning. She must undergo direct radiation to her brain and her yes for 12 days. Please, if you can spare them, send your prayers over the next couple weeks. Pray that the side effects are minimal, pray that she feels good throughout, and most of all pray that this does its job and kills every last cancer cell hiding in these areas. Thank you for your love and support, we are at another turning point in Phoenix's recovery and we need you now. God Bless.

Update 7/25: Another milestone: Phoenix finished her radiation treatments today! She has been feeling well...playing, swimming, and being a 6 year old. I cannot express how blessed we feel to have escaped

the long list of possible side effects so far. We are so thrilled to be back at home! Her next set of chemotherapy begins August 6th.

Fay Roberts: Lady Fay went back into the Hospital today (7/30) after a routine blood checkup revealed that her numbers were all off. She was admitted and had a throat scope, but no results yet. Richard Lochner: Yes, I am doing well in my fourth week. I'm taking therapy 3 times a week, and moving from a walker to a cane. Flexion in the knee is about 100 degrees. It must be 120 to get back in my Crossfire. Richard

Virgil Humphrey: Please forward to the rest of the gang. All is OK with us and found out today that my knee surgery has been changed to July 9th instead of July 23rd. Tell all hello from the north! Virgil

Update 7/10: Hello to the guys. This is just to advise those that are interested that I had my right knee replacement surgery this morning about 10:30 A.M. (Monday, July 9). Everything went very well; doctor completed his work in about an hour and reported that everything had gone as expected. I was back in my room within the next hour or so. I have my leg wrapped and it is immobile and packed with an ice pack; but I feel very good. I did have three nerve blocking shots, so today I have no pain! I know, tomorrow is another day. I did get up today, first just on the side of the bed, then standing on the floor, then a couple of steps--without putting weight on the repaired knee--to a chair. A couple of hours later, made a "walking" trip to the restroom. I did stay in the chair with my legs up and the chair tilted back a bit (sort of like my lazy boy chair at home) for about four hours. We are so very thankful for all of the good things that happened today. They really take good care of a fellow here at Indy Ortho. Real therapy begins tomorrow.....! Thanks for all of the prayers and concerns. My room # is 209, at Indiana Orthopedic Hospital, 8400 Northwest Blvd, Indianapolis IN. My room phone # is (317) 956-6209. My cell phone is 765-652-1020. Update: 7/26: Thoughts perhaps I should talk some time and bring you all up to date on my condition and issues that have been plaguing me since the first part of July regarding my knee surgery afterwards! My right knee replacement was originally scheduled for July 27 2012 got rescheduled for the 9th of July due to a conflict in the surgeon plans and hi schedule. I found this out while we were still in Red Lake on our fishing trip; it had something to do with the physician's schedule. Anytime, my other choice was to have it done in late August but I wanted it done earlier, thus the July 9th date. We did blood etc. prior to going in on the 9th of July and that all worked out well. The only problem from the registration and tests indicated that I was just above the anemic line with my blood prior to surgery but they indicated they could take care of that problem as we went along in the surgery. Surgery went very well and we were back in recovery at about 1:30 pm; pretty much what they had talked about for the surgeon to do his work. Recovery went well and they had me up on the side of the bed by 5:00 pm. Had some dinner and began to wait until the next morning to see how things were doing in the morning. Therapy began on Tuesday morning with bed exercises and some standing exercises also to start in getting things back into shape. Tues and Wed went fine and they decided to send me home on Wed evening, otherwise scheduled for Friday trip home. Got home on Wednesday and immediately got set up with a physical therapist and began to work on the start of healing. My bowels had not been friendly to me before we had gone into the hospital therefore I was admitted and did not improve while I was in the hospital. They kept asking if I had passed gas today, etc which I told them I had, but no bowel movement. This went on until a few days after we arrived at home, when I sent to Janice to drug store to get me one of those "self-inflicted enemas. We got some relief but not much. I had a call from Dr Pike's office in Indy on Monday, July 23rd to see (blood man, Dr. Hupfer) advising me that I needed to get to my family doctor as soon as possible as my blood count # was still in the 8 range when it needed to be around 12 or so. We called Bourdeau's office and made an appointment for Monday

afternoon regarding the low blood count. We went to get a blood drawn so we would have it for the afternoon of our appointment with Boudreau. After consultation with him, the decision was made that I needed to get some blood transfusions as soon as possible. The two options, the first being to start taking pills and gradually building by system up or just to get in and have two units of blood for a more quicker response to the problem far outweighed the first option. So arrangements were made at my doctor appointment at 4 p.m., this is the way we needed to do it, he made the necessary calls, set up a plan at the Lebanon hospital to get the transfusions done before we went home Monday evening. Finally, after some 11 hours at about 3:00 a.m. on Tuesday morning we were allowed to come home, getting home and in bed by 4 a.m. Other than that we are doing fine and are resting at home. The surgery has gone well and P.T. is going good also. I have therapy 7 days a week to get all back in order. My next appointment with Boudreau will be on July 30th and Dr Hupfer, my next visit with him is rescheduled for August 24th at Indy. Thanks to all of you who sent cards, etc., I'm usually around here about all day except for a few little walks when the weather will permit. I would be glad to see any of you that would like to stop and in say hello! God bless each of you and your families!!!! Brother Virgil

Adam broke his leg in 2 places, his ankle, his collar bone, and has abrasions on his right arm and leg. He got a concussion and had to have 6 staples in his head. He was a Past District Deputy Grand Master of the 21st Masonic District and a recipient of the Joseph Warren Medal from Grand Lodge. He was elected Most Excellent High Priest of Jerusalem Chapter No. 3 in 1957, prior to that he had served as Excellent King, Excellent Scribe, Principal Sojourner, Royal Arch Captain, Second Veil and treasurer for many years. He became a member of Knight Templar Calvary Commandery No. 3 in 1952, where he served as Eminent Commander, Generalissimo, Senior and Junior Warden, Standard Bearer, Sword Bearer and was Prelate for many years. He served as Grand Commander from 1977-1978. Prior to that, he had served as Deputy Grand Commander, Grand Generalissimo, Grand Captain General and Grand Recorder. He was a member of the York Rite where he had served as Governor from 1981-1982, prior to that he had served as Deputy Governor and Chancellor. In 1978, he was conferred in Parkersburg by Wheeling Valley Consistory, where he served as secretary for many years. He was a member of Nemesis Temple of The Shrine and Order of the Eastern Star, Chapter 14 where he had served as Past Worthy Patron. Other Masonic Degrees and Orders Courtney had received include Red Cross of Constantine, Sovereign; Order of High Priesthood, Chaplain, Allied Masonic Degrees, Secretary, Holy Royal Arch K.T. Priests, Past Excellent Chief, Knights of the York Cross of Honour and Past Prior Mt. State No. 55, Registrar Emeritus. He was Past Department Commander of the East Central Department of the Grand Encampment Knights Templar of the United States of America. He was a faithful member of Emmanuel Baptist Church, Parkersburg. Mr. Jones is survived by two daughters, Mary Ann Hensley of Reedville, Va., and Caroline Lee Patterson of Marietta; four grandchildren, Leigh Ann Patterson, Katherine Knight, David Knight and Courtney Knight; and three great-grandchildren, Madison Renee Knight, Isaac Channell and Tallyn Arbogast.
